

The current requirement from global policy for cars is 120g CO₂ per 1 km.

In 2022 SECURITAS ČR s.r.o. was implemented new waste management system. This system is supported by certification ISO 14001. We separate 7 basis kinds of waste in our all sites.

We support our waste management with environmental project with company REMA Systém, a.s. which process the electrical waste. In 2022 was separated of 160 pieces of electrical waste in total weight of 676 kg.


