Each section has sub sections, and you will find links to a number of handy guides and reference materials. Just click on the appropriate section/sub section in the index and you'll be taken to the relevant page.



Email

Your Stanley email address
On day one and for the immediate future, the way in which you use your Stanley

email address will not change.

Your email address will remain the same and you'll still have full access to your Stanley emails and contact list.

Please continue to use your Stanley email, as you did before close, for all internal and external emails and for all existing Stanley application/ system logins.

Your Securitas email address

All Stanley employees joining Securitas UK will receive a Securitas email address.

You will only use this email address to log into the Securitas systems you need access to i.e. Learning Hub (Learning Management System) and Workplace.

You will not use your Securitas UK email address for receiving or sending emails – you must continue to use your Stanley email address.

Important information!

You will receive two emails from Do_Not_Reply@securitas. uk.com

The first email will contain your new employee number (PIN).


The second email will contain:

- Your new Securitas.com email address
- Your user nameYour password will be in the following format:
- your new six digit Securitas employee number (PIN) followed by your National Insurance (NI) number (all uppercase with no spaces)
- For example:

Employee PIN: 012345 and National Insurance (NI) number: AB987654C the password would be 012345AB987654C

Your email signature

From day one a legal disclaimer will be added to your outbound emails by the Stanley Black & Decker IT team. This disclaimer states that although you are maintaining your Stanley Security email, you are no longer an employee, agent, or representative of Stanley Black & Decker.



Accessing systems

Your logins

Your current system logins will not change on day one; however, you will lose access to some of the Stanley Black & Decker applications on day one including SBD Workplace by Meta, SBD PeopleSoft and SBD Concur.

You will be given access, where appropriate, to Securitas applications. These include Securitas Workplace, The Learning Hub (Learning Management System), Timegate, Miracle (Payroll) and Miracle (HR), Gray Dawes (travel) and Concur (expenses).

Details of login credentials for each application are detailed in the relevant section.

Password reset tool (SSRPM) for your Securitas UK account

Securitas UK has a password reset tool called Self Service Reset Password Management (SSRPM.)

It is important that you enrol to use SSRPM as soon as possible as it will make unlocking your account, changing your password, or resetting a forgotten password much quicker and easier, without the need for contacting the Securitas Helpdesk.

Password reset

It is important that you enrol to use SSRPM as soon as possible.



In Securitas we use Multi-Factor Authentication (MFA) as an extra layer of protection that is added to the sign-in process.

When accessing accounts/ systems MFA can be configured to add extra authentication via an app on your mobile device (Microsoft Authenticator App), an SMS/text message or a phone call in addition to your password.

Microsoft MFA can be configured by following the prompts when logging on to a Microsoft system for the first time or by going to https://aka.ms/mfasetup

Get the app

If you don't already have the Microsoft Authenticator app installed on your phone, please download the app from the Google App Store or Apple Store. The first time you log in to Microsoft using your Securitas account you will be prompted to set up MFA and will give you instructions.

To setup your Microsoft
Authenticator you will need to
log into your Securitas Microsoft
O365 account with your supplied
Securitas username (email
format) and password – you will
receive a prompt to set up MFA.

Do you already have the app installed?

If you already have a Stanley O365 account using MFA you will need to log out of your Stanley O365 account. You may even have to use an Incognito window in your browser to stop it automatically logging you back in with your Stanley Microsoft account.

VPN

Please use the existing Stanley VPN application when using company devices until further notice.

Intranet

Access to the Stanley Black & Decker intranet has been removed from day one.


Securitas UK does not have an intranet per se however Sharepoint, part of the Microsoft Office 365 suite of applications, is widely used by the business.

Tools and applications

Securitas Citrix access

A small number of Stanley HR employees may need to access internal Securitas applications such as Miracle (Payroll), Miracle (HR) or Timegate.

If you are one of these users, you will access these applications via our Securitas UK Citrix portal: https://citrix.securitas.uk.com

Please use your new Securitas UK logon details i.e. your user name (your new Securitas email address) and your password.

Important information!

The Securitas UK Citrix Portal uses MFA (the Microsoft Authenticator app) so make sure this is set up before you try to use Citrix.

You will be added to a number of key Securitas UK workplace groups including:



From day one please use Securitas UK Concur to claim your expenses: https://www.concursolutions.com/

Important information!

- Logon ID = firstname@ lastname new employee number
- e.g. john@smith222001

The password is set up as Welcome1.

Please change your password when you login to Securitas UK Concur for the first time.

Gray Dawes (Travel booking)

From day one please use the Securitas UK Gray Dawes travel booking system for all your travel and hotel booking requirements: https://www.gdg.travel/login/

Your User ID will be your Securitas email address (@securitas.com).

Please select the 'Forgot Password' link on the login page. This will generate an email to you, asking you to set your password. This email link will only be valid for 24 hours.

Collaboration platforms

There are no major changes to the collaboration platforms you currently use e.g. Teams, SharePoint or Zoom.

Please continue to use the tools you are familiar with for file sharing, meetings, and general collaboration. Any future proposed changes will be communicated in advance.

Devices

Your laptop

Initially, there will be no change to your laptop – please continue to use your existing device(s) until further notice.

We will gradually replace or reimage these devices over the next few months and provide full details nearer the time.

Your mobile phone

Initially, there will be no change to your current mobile phone. Continue to follow your Stanley Security Mobile Policy.

You will receive a notification when your device is ready to be replaced together with full details of the process.

Data

Cybersecurity

During times of transition, criminals will try to profit from the situation by tricking people into doing something that allows them to steal money or steal their access credentials to Stanley or Securitas systems.

You have an important responsibility in preventing this from happening by:

- 1. Ensuring you are aware of, and comply with, any procedural controls and lines of authority when it comes to effectuating payments; don't act on sensitive instructions when you cannot confirm the authenticity of the instruction's origin
- Ensuring you are aware of typical methods used to steal credentials via email, phone calls and other forms of communication; your access credentials are personal and should NEVER be shared with anyone
- 3. Being careful with hyperlinks in emails: think before you click!
- 4. Reporting anything suspicious to your line manager, or if it concerns something IT related, please report the activity to your IT helpdesk.



Your IT help

There are no changes to your current IT support. Please continue to use your current IT help desk and support teams for any issues related to your company devices and applications.

Congratulations! You are now officially an employee of Securitas Security Services Ltd and we are thrilled to have you join our team.

In addition to all the IT information, there is some really important information we'd like to share about being an employee of Securitas – the most important one is pay, so let's start with that!

Your pay

You will continue to be paid on the same day and in the same way as you are now. You will also still be able to login to the platform you use to obtain your payslip.

From September, you will receive your payslip by email from Securitas to your Stanley email address.

If you have any queries about your pay, please talk to your line manager, as you would normally do.

Your new employee number

You will be notified of your new Securitas employee number as part of your welcome letter from Securitas. (In Securitas your employee number is often referred to as a pin number).

It's important you have your new number to hand as you will need it to set up your new Securitas email account, when you login for the first time.

PAYE reference number

Your PAYE reference number will not change.

Your pension benefits

Pensions are an important part of your benefits package and we understand the importance of helping you to save for your retirement. The level of employee and employer pension contributions remain unchanged following completion of the deal.

If you are currently an active member of the Stanley Black and Decker UK Pension Plan, the intention, subject to consultation, is that we will enrol you into the Securitas Group Personal Pension Plan from 1 September 2022. If you are impacted by this you should have already received a letter confirming this.

The Securitas Group Personal Pension Plan is administered by Legal & General and offers a range of useful features and tools to help you plan your retirement. You can find out further details by visiting https://www.legalandgeneral.com/workplace/s/securitas

If you are currently a member of a different UK pension plan then this will continue for the time being. We are in the process of reviewing all of the various pension arrangements provided by Stanley and should any changes be proposed in the future we will be sure to contact you and provide details of the changes and your options as soon as possible.





Organisation

There are no immediate organisation design changes: the same manager you reported to yesterday will continue to be your manager.

Premises

There will be no changes to STANLEY premises from day one so please continue to use STANLEY premises as your currently do.

Company cars

If you drive a Stanley vehicle everything will stay the same on day one - please use your existing process and procedures for escalations for breakdowns, servicing, fuel cards etc. If you have a specific query you can't find the answer to please email fleet@securitas.uk.com

IT

At a date, to be decided after close, your email, contacts, Teams and SharePoint content will be migrated to your new accounts in Securitas Office 365.

Transition support

STANLEY Security and Healthcare and Securitas have entered into a 12-month Transition Services Agreement (TSA) for various services and systems to ensure a seamless transition to Securitas Electronic Security.

Brand

The STANLEY Security and Healthcare brand will transition to the Securitas brand. Some minor rebranding will commence immediately, such as e-mail addresses, e-mail signatures, business cards, client communication and website.

Other, more significant, rebranding will commence in 3-12 months, including invoices, uniforms, photo ID badges, vehicles, facilities, decals and clients' signage.
